CAMBRIDGE YEAR 10 SCHOLARSHIP TERMS AND CONDITIONS

ELIGIBILITY

- 1. Admissions or progression into Year 10 Cambridge Programme
- 2. Must be enrolled and accepted as a full-time student at Sunway International Schools.
- 3. Open to Malaysians and International citizens.
- 4. Must have good record of discipline and conduct.
- 5. All documents relevant to the scholarship must be verified by relevant authorities.
- 6. Must have obtained minimum 6As or 80% in at least 6 subjects in Year 9 final school results for 25% waiver in tuition fee or obtained a minimum on 9As or 80% in at least 9 subjects in Year 9 final school results for 100% waiver in tuition fee.
 - i) English ii) Mathematics iii) Science iv) Six (6) other subjects
- 7. Must achieve a minumum score of 125 in both verbal reasoning (English proficiency) and Quantitative Reasoning (Mathematics) in CAT4 assessment in order to be eligible for 100% waiver in tuition fees.
- 8. Candidates are required to attend an interview and write a presonal essay (at least one page long) on why you deserve this scholarship.

SCHOLARSHIP VALUE

The award of scholarship takes the form of a 25% or 100% waiver on tuition fee only, this is not a cash award. There is a quota for the number of receipients for this scholarship.

APPLICATION

Complete the application form and submit it along with the following documents to the School Admissions Office by the closing date of 1^{st} June or 1^{st} December of each year.

- 1. Certified true copies of academic results
- 2. A copy of Identity Card/Passport
- 3. School leaving certificates or testimonials
- Letter of recommendation from former school's principal to certify that this student has a good behaviour record, having not come under school-wide disciplinary action during his/her school years.

Important Note:

Applicant may be required to attend an interview with the School Scholarship Committee. **Application received after the closing date will not be accepted**

TERMS & CONDITIONS

- 1. Applicants must meet the criteria and requirements as stated above before an offer of award can be made. Applicants who do not qualify will be automatically disqualified without prior verbal or written notice.
- 2. The latest term's/semester's report may be considered if the final report for Year 9 has not been released at the point of application/intake. However, the scholarship will be awarded only when the official/actual results are provided. The official/actual results must meet the eligibility requirements.
- 3. The scholarship is neither transferable nor exchangeable for cash or other alternatives.
- 4. In the event that the scholarship recipient withdraws from, is suspended or terminated by Sunway International Schools at any point of time before the completion of study, the scholarship shall be automatically terminated.
- 5. Should such a withdrawal, termination, or suspension occur, the School reserves the right to request the scholarship recipient to reimburse Sunway International Schools the scholarship amount he/she had been awarded.
- 6. Should the scholarship recipient withdraw due to medical reason, the reimbursement of the scholarship sum may be waived at the absolute discretion of Sunway International Schools. The scholarship recipient must submit supporting medical report from doctor(s) acceptable to Sunway International Schools for such consideration.

- 9. Annual renewal required, and to maintain the scholarship award, student must maintain at least 70% average in their final results every semester. The scholarship may be forfeited without renewal if the student does not meet the criteria.
