

- The bursary is only applicable for subsequent enrolment.
- The bursary is in a form of tuition fee waiver. It shall not be deducted from any general, registration, application or exam fees.
- The final decision to grant the bursary is at the sole discretion of the Admissions and Administration Office of Sunway International Schools.
- For students who are eligible for several forms of discount/bursary by Sunway Education Group or Sunway Group (e.g. Staff Discount), SIS Family Bursary awarded will be applicable on the net balance of the tuition fee payable after the deduction of the relevant discount/bursary and NOT on the total sum of tuition fee.
