ACADEMIC SCHOLARSHIP TERMS AND CONDITIONS

ELIGIBILITY

- 1. Admissions into GRADE 7 (Ontario) or YEAR 8 (Cambridge).
- 2. Must be enrolled and accepted as a full time student at Sunway International Schools.
- 3. Must have obtained six (6) As in the following subjects in Grade 6 (Ontario) or Year 7 (Cambridge) or equivalent final schooling results:
 - (i) English (Comprehension and Writing), AND
 - (ii) Mathematics, AND
 - (iii) Science, AND
 - (iv) Three (3) other subjects (only one (1) second language will be taken into consideration)
- 4. Open to both Malaysian and International student applicants.
- 5. Must have good record of discipline and conduct.
- 6. All documents relevant to the scholarship must be verified by parents/guardians and/or relevant authorities.

SCHOLARSHIP VALUE

The scholarship quantum awarded takes the form of a 25% waiver on tuition fee only; this is not a cash award.

APPLICATION

Complete the application form and submit it along with the following documents to the School Admissions Office by the closing date of 1^{st} June or 1^{st} December of each year:

1. Certified true copies of Grade 6 (Ontario) or Year 7 (Cambridge) or equivalent final schooling results;

2. Letter of recommendation from former school's principal to certify that this student has a record of good behaviour, having not come under school-wide disciplinary action during his/her school years.

Important Note:

Applicant may be required to attend an interview with the School Scholarship Committee. Application received after the closing date will not be accepted.

TERMS & CONDITIONS

- 1. Applicants must meet the criteria and requirements as stated above before an offer of award can be made. Applicants who do not qualify will be automatically disqualified without prior verbal or written notice.
- The current year's trial/forecast results are accepted if the official/actual results have not been released at the point of application/ intake. However, the scholarship will be awarded only when the official/actual results are provided. The official/actual results must meet the eligibility requirements.
- 3. The scholarship is neither transferable nor exchangeable for cash or other alternatives.
- 4. In the event that the scholarship recipient withdraws from, is suspended or terminated by Sunway International Schools at any point of time before the completion of study, the scholarship shall be automatically terminated.
- 5. Should such a withdrawal, termination, or suspension occur, the School reserves the right to request the scholarship recipient to reimburse Sunway International Schools the scholarship amount he/she had been awarded.
- 6. Should the scholarship recipient withdraw due to medical reason, the reimbursement of the scholarship sum may be waived at the absolute discretion of Sunway International Schools. The scholarship recipient must submit supporting medical report from doctor(s) acceptable to Sunway International Schools for such consideration.
- 7. To maintain the scholarship award, students must maintain at least 85% average in their overall final results in every semester. If the student does not meet the average score, the scholarship may be forteited without renewal.
- It is compulsory for scholarship recipients to represent the school in relevant events as and when required by Sunway International Schools. Recipients who are unable to participate in such events are required to submit a written explanation and supporting documents to the Principal's Office stating the reason(s).

- 9. In addition to the 40 community service hours (if applicable), scholarship recipients may be required to do additional hours of community service per year, as approved by the Principal/assigned staff, in and outside of Sunway International Schools.
- 10. The recipient may also be requested to assist in the School's promotional activities as and when required by the Principal/assigned staff.
