MUSIC SCHOLARSHIP TERMS AND CONDITIONS

ELIGIBILITY

- 1. Aged between 12 to 18 years old.
- 2. Must be enrolled and accepted as a full time student at Sunway International Schools.
- 3. Must have minimum at least 2 years of experience in local and international musical exposures.
- Have obtained Grade 5 certification by an international examination board such as RockSchool, ABRSM, Trinity, etc., or other qualifications deemed acceptable by the SIS Scholarship Committee.
- 5. Open to Malaysian citizens only
- 6. All documents relevant to the scholarship must be endorsed by parents and/or relevant authorities.

SCHOLARSHIP VALUE

The award of scholarship takes the form of a 25% waiver on tuition fee only; it is not a cash award.

APPLICATION

Complete the application form and submit it along with the following documents to the School Admissions Office by the closing dates 1st June or 1st December:

- 1. CV (resumé) indicating academic and extra-curricular activities including performance, sports, arts, or others.
- 2. Certificate or references to evidence student's musical exposures.
- 3. Two letters of recommendation, one each from music instructor and former school's principal.
- 4. A 3-5 minutes videotaped performance of a piece of music of choice or a portfolio comprising 2 to 3 contrasting works with accompanying audio recording.
