TERMS & CONDITIONS

- 2. The current year's trial/forecast results are accepted if the official/actual results have not been released at the point of application/ intake. However, the scholarship will be awarded only when the official/actual results are provided. The official/actual results must meet the eligibility requirements.
- 3. The scholarship is neither transferable nor exchangeable for cash or other alternatives.
- 4. In the event that the scholarship recipient withdraws from, is suspended or terminated by Sunway International School at any point of time before the completion of study, the scholarship shall be automatically terminated.
